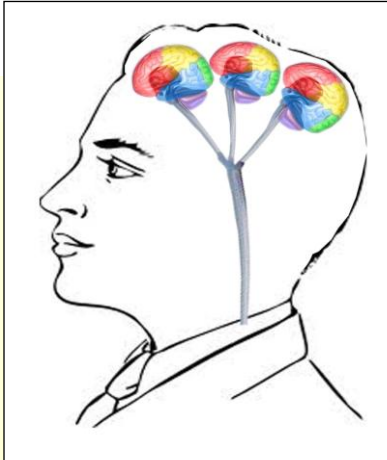

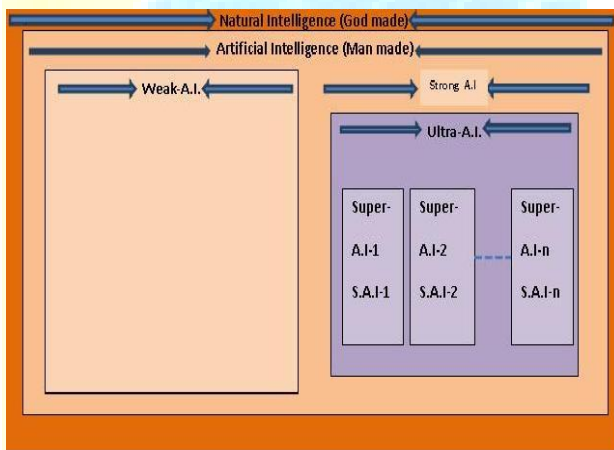

## 3. U.A.I. Routing Model:

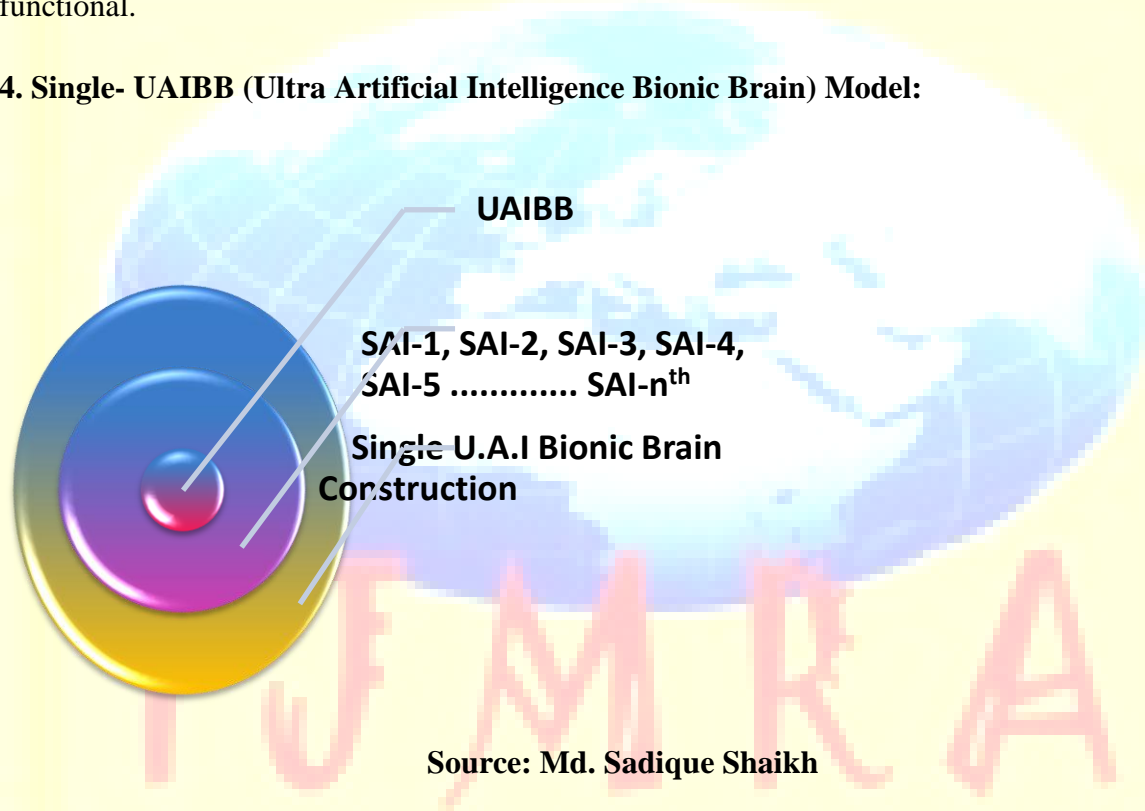

**4. Single- UAIBB (Ultra Artificial Intelligence Bionic Brain) Model:**



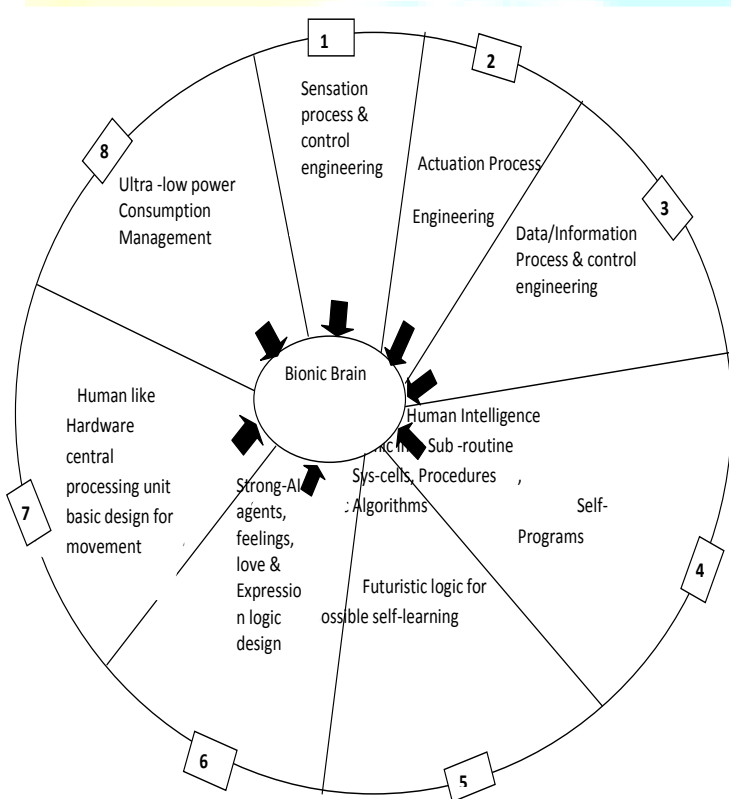

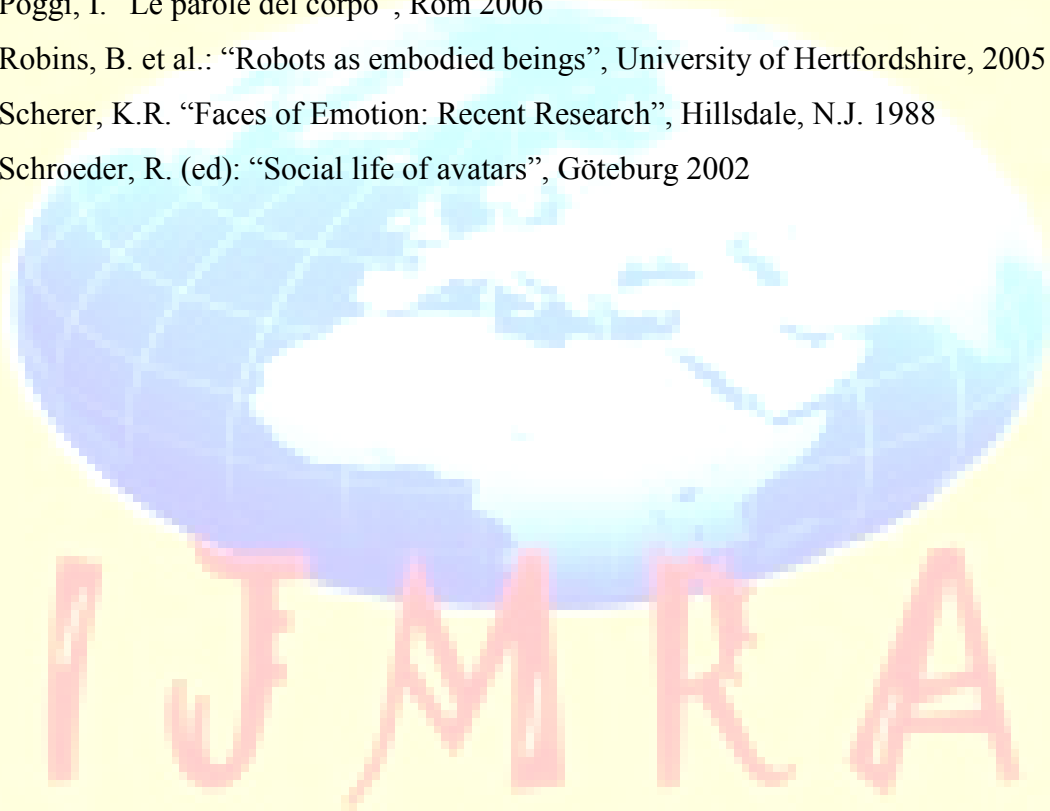
